New Sword Policy for the Diocese of Arlington

In January, District Master Thomas A. Trudeau announced a new policy with regards to the use of swords in the Diocese of Arlington. This new policy reflects the desires of our new Bishop, the Most Reverend Michael F. Burbidge, and it pertains specifically to Masses and other liturgies in which he is personally present. The policy reads as follows:

"With the installation of the new Bishop in the Arlington Diocese, we reviewed our Color Corps procedures to ensure they comply with the intent of the new Bishop.

"Bishop Burbidge has no objections to the Color Corps carrying swords at his liturgies if they remain in their scabbards.

"Based on this guidance, the current Color Corps policy for liturgical events when Bishop Burbidge is present, shall be modified.

"When Bishop Burbidge is present, Color Corps members may carry swords but they will not be un-sheathed. Swords will not be drawn, at the carry, or presented during liturgies in which the Bishop is present. All salutes will be hand salutes.

"Color Corps activities at local parish events, when the Bishop is not present, is not changed. Swords may be used with the permission of the local Pastor.

"This guideline does not affect current policy in the Richmond Diocese."

Keep in mind, we are not permitted to even wear the swords at liturgical events that occur at the Basilica of the National Shrine of the Immaculate Conception in Washington, D.C. As Sir Knights, we should not question the motives of our Supreme Pontiff, Bishops, or Priests... it is part of being in Solidarity with them in deference to our Founder.

Renewal of Obligations
